

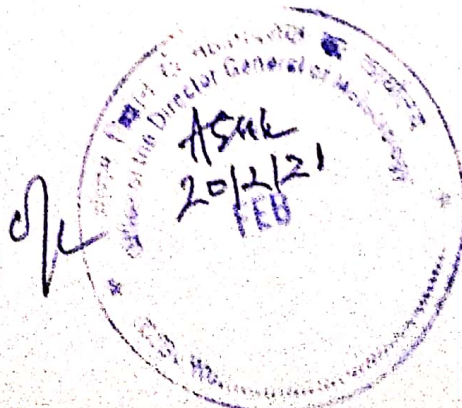


"All the members of the Union are eligible to be a member of the union Council and office-bearer of the Union if he/she has paid his/her annual union subscription of the current year prior to the date of election"
