In continuation to NGSU meeting held on 14.07.2015 and as advised by admin to submit few recruitment rules from other departments wherein the posts are described either in the classification column or in the preface of the Gazette notification from the departments.

Rupesh Pandita (Treasurer) 1. Ministry of Science and technology (Science and Engineering Research Board): Classification "Scientific and Technical"

Rohatas (CEC Member) 2. Ministry of Science and technology, Department of Biotechnology: Junior Analyst (Technical) in the preface and also in the name of the post column.

T. K. Mandal (CEC Member) 3. Ministry of Science and technology, Department of Biotechnology: Group A Scientific posts only in the preface whereas in the classification column only General Central Service (Group 'A' Gazetted) is notified.

- 4. Border Security Force: Group 'C' Non-Gazetted, combatised Para Medical staff Technical posts. And combatised is mentioned in the classification column too.
- 5. Border Security Force: Border Security Force(General Duty Officers) Recruitment rules 2001 where as in the classification column mentions "General Central Service (Group 'A' Gazetted, Non-Ministerial)" is notified.
- 6. Ministry of Defence: Defence Research and Development Organisation Recruitment of Group 'A', Group 'B' and Group 'C' technical post in the preface with Flexible complementing scheme of

promotion and the classification itself is defined as "Classification: Civilian in Defence service"

Vijay Pal (CEC Member) 7. Ministry of Defence: Defence Research and Development Organisation Technical cadre Recruitment rules, 1995 page 10 classification itself is defined as "Classification Civilian in Defence service" and also mentions Defence Research & Technical service in category III.

8. India Council of Medical Research has also classified the post as "Group C, Technical, Non-Gazetted."

All these recruitment rules imply that the post have to be described either in the preface of the notification or in the classification column to extend the pay commission benefits such as FCS mode of promotion, extra allowance payment and etc.

The industrial staffs are covered by industrial dispute act where as the central Govt. establishments such as IMD which is an operational service provider to the nation and is working round the clock and in accordance to the pay commission recommendation the recruitment rules should reflect the same.

This union is of the opinion that due to conflict between Govt. policies, Pay commission recommendations and IMD mandate that we are unable to get the complete benefits given by Govt. of India and pay commissions.

Therefore once again I request of behalf of NGSU to include "Scientific/operational and Technical/operational" in the recruitment rules of Group 'B' and Group 'C' officers and staff of IMD.
