Present Status on points raised by General Secretary, IMD NGSU is given below

<u>S.No.</u>	<u>Point</u>	<u>Present Status</u>
1.	Implementation of Flexible Complementary Scheme (FCS) for Non-Gazetted Staff.	Implementation of FCS for Non-Gazetted Staff, a detailed Scheme recommending implementation of a "Merit Based Promotion Scheme" in respect of Group "B" & "C" "Scientific and Technical staff of IMD was forwarded to the Admin. Ministry on 11 th May, 2010. During further discussion on the matter on 9 th November, 2010, the MoES officials intimated that the proposal is under consideration of DoP&T. No further information in this regard has been received so far.
2.	Recruitment against vacant posts in all cadres	Amendment of Recruitment Rules as per 6 th CPC norms are under process and fresh recruitment can only be initiated once amended proposals are duly approved by all the authorities. Recruitment process for posts for which Recruitment Rules/ Model Recruitment Rules is approved, the case of filling up of 28 Nos. of posts to the cadre of LDC by Direct Recruitment is under process.
3.	Revival of JCM at HQ level in New Delhi & Regional level in RMCs	Several letters were circulated to all General Secretaries of IMD Unions/ Associations to elect their staff side leader as per DoP&T OM No. 3/12/2006-JCA dated 30.11.2007 to hold the regular meetings of Departmental Council, but no intimation has been received so far.
4.	Promotion list of all cadres	Promotion lists in Gr. 'B' & 'C' Non-Gazetted cadres are under process as per DoPT. OM. NO.36012/45/2005 – Estt. (Res.) dated 10.8.2010.
5.	Merger of AM-I and AM-II	Case for merger of Asstt. Met. Grade-I and Asstt. Met. Grade – II was discussed in the meeting held on 14 th May, 2009 under the Chairmanship of DGM and it was decided in the meeting that merging of AM-I and AM-II may be examined by the Cadre Review Committee which has already been constituted by DGM.
6.	Merger of LA-I and LA-II	No such proposal is under consideration.
7.	Revision of OTA & Night Weight age allowance	The OTA and Night weightage is as per the rate notified by the Govt.
8.	Minutes of the meeting held with the DGM on 01.11.2010	It was an informal meeting therefore the minutes were not recorded.
9.	Promotion avenues for Draftsmen/Met. Attdt./ Canteen Staff.	Proposal for merger of D'man cadre with that of Sc Asstt. has not been agreed to by the Admin. Ministry. However, a proposal for re-consideration of either the merger proposition for evolve, a separate channel of promotion for the cadre is under consideration with the competent authority. Model recruitment Rules in respect of Canteen employees has been notified by DOPT. Promotion avenues will be as per the Recruitment Rules.
