MBPS: As informed by DDGM(A&S) that the committee formed under the chairmanship of Dr. Devendra Pradhan, Scientist-F has finalized their report on MBPS and will submit the same to the ministry by end of this month. It is requested that Dr. Pradhan being the senior most Scientist in IMD may be given the responsibility to implement the MBPS in IMD. He may be authorised to accord necessary administrative and financial approval and allowed to deal as a nodal officer with all external bodies such as DoPT, Ministry of Finance etc for timely implementation of the report.

Promotion lists: It has come to knowledge that due to technical and administrative reasons all the promotion lists have been kept under abeyance. We would like to bring to your kind notice that, DOPT vide their order No. 3/1/2017-CS-I(D) dated 27.09.2018 has released the promotion list of CSS officer's. Taking this as an example we request that all promotion lists on a similar conditions may be released in IMD.

Recruitment in MTS Cadre: As we know that there is acute shortage of MTS staff in IMD. Recruitment of MTS staff has not done after the year 2003. It is difficult to run the office specially observatories without a permanent MTS. Since Mali committee report is in its initial stage it is therefore requested that recruitment in the MTS cadre may be done at the earliest so that posts of MTS can be saved from abolition.


Compensatory off realization: we expressed that due to staff shortage and many other administrative reasons the staff are accumulating compensatory off to an amount of 1000 hours. These compensatory offs are need to be realized or staff should be permitted to avail the same. Secretary being very considerate and has assured that they will make a policy for compensatory off realization.

Approval of JS(Admin) & Financial Adviser for operational staff: As per DoPT order No.A27016/03/2017-Estt.(AL) dated 19.06.2018, the concerned Administration wing of the Ministries will prepare a list of operational Staff with full justification based on the definition of operational staff with the approval of JS(Admin) and Financial Adviser of the concerned Ministry. It is requested that the approval of JS(Admin) and Financial Adviser may be accorded and communicated to IMD at the earliest so that pending bill of OTA may be cleared. At present OTA bill of last 1.5 years are pending at IMD.

All the above are long pending issues of IMD and need to be addressed. It is requested that necessary action may be taken at the earliest to resolve the above points.
