

Point No.1 Extension of Recognition of all Six Service Association/ Unions.

:- Representatives were briefed about the present status of case of Recognition of Union/ Association. The deduction of subscription will be made as per the existing subscription.

Point No. 2 Cadre-Restructuring of all cadres and finalization of R/Rules of S.O.-I/II/III

:- The status of cadre restructuring of cadres of SC-I/II/III was discussed. Draft will be shown to the office-bearers of the Union/Association.

2. The report of the R R Mali Committee has been sent to MoES and the copy of the same will be provided to the Union/Association.

Point No.3 Implementation of CVC guidelines regarding rotation policy.

Point No. 4 Review of Transfer Policy.
