
Sub: **Minutes of the Meeting dated 20-10-2016 with DGM.**

Minutes of the meeting under the chairmanship of DGM on the points raised by the Union/Association.

A meeting was held on 20-10-2016 at Conference room, Sixth floor under the Chairmanship of DGM. The following officials have attended the meeting.

1. Dr.S.K.Roy Bhowmik, Scientist 'F' Dy. DGM (A&S)
2. Smt. Samanti Sarkar, Scientist 'D' Director (Establishment)
3. Shri R.V.Singh, Asstt. Met. Gr. I. Meteorologist B (Estt-III)

along with office bearers of the Union/Association of IMD (Annexure I).

At the outset Chairman welcomed all officials present in the meeting and requested members of the Union/Association of IMD to present their demands/issues on priority. Members of the Union referred to their meeting dated 29-09-2016 and the brief summary of discussion is presented below:

Point No.1 Simplification of mandatory Training programmes.

The members expressed that the person who could not qualify in one or more papers in mandatory Training programmes of the Department are compelled to wait for prolonged time for re-appearing in concerned paper and subsequent result thereafter. This entails expenditure on Govt. Exchequer and sufferings to employees and their promotional prospects.

DGM agreed that the Training programmes of the Department will be streamlined and simplified so that the employee who could not qualify in Exam will be allowed to re-appear in paper immediately after closure of Training schedule till the concerned employee qualifies in exam before leaving for his parent office. CTI Pune is requested to workout necessary modalities for implementation.

Point No. 2: Uploading of R/Rules in DoP&T site.

DGM clarified that the matter is under progress with MoES.

[ACTION: E-I/III]

Point No.3: Promotion List from AM-II to AM-I and S.A to AM-II.

DGM briefed that Promotion List from AM-II to AM-I shall be released shortly and S.A to AM-II shall be released by November end.

[ACTION: E-I]

Point No. 4: Re-distribution of restructured Group A Scientific posts of S.O-I/II/III

DGM briefed that re-distribution of restructured Group A Scientific posts of S.O-I/II/III will be done after approval of R/Rules from DoP&T/UPSC.

Point No. 5: Compassionate Appointment:


DGM briefed that committee has been formed and the list will be finalized..


[ACTION: DGM (E-II)]

Point No. 6: Canteen Staff:

DGM stated that file concerned to functioning canteen staffs to MTS has been cleared and will be implemented soon.

Point No. 7: MACP Cases of MTS:

DGM urged that MACP Cases of MTS may be expedited on priority.

Point No. 8: Pending Implementation of 6th CPC recommendations in r/o Industrial Staff:

DGM briefed that the case may be expedited on priority

[ACTION: DGM (E-III)]

Point No. 9: Consideration of Transfer request on availability of vacancy:

DGM briefed that if the vacancy is available at the station of choice, the cases may be expedited on priority basis provided the person has completed the minimum requisite period.

[ACTION: DGM (E-I/II)]

Point No. 10: Sports Meet

DGM briefed that the Sports Meet may be taken up on Ministry level. Nomination of all constituents of MoES (Subordinate/autonomous/attached Offices), may be invited. The case will be initiated by IMD.

[ACTION: DGM (Welfare Section)]

Point No. 11: Re-employment of Ex-IMD employees.

DGM briefed that as per the requirement of stations, the re-employment of Ex-IMD employees can be taken up as per extant rules through walk-in interview.

[ACTION: DGM (Welfare Section)/E-II]

Point No. 12: Shortage of stationery.

DGM briefed that as per the requirement GS (Purchase) may take necessary action as per inputs obtained from all units of IMD.

[ACTION: DGM (GS-Purchase)]

Point No. 13: Office-Accommodation for IMD GOA.

General Secretary, IMD GOA raised the point that Gazetted Officers Association does not have any Office accommodation whereas the same has been provided to five Association(s)/Union(s) of IMD. General Secretary, IMD GOA requested that similar facility be provided to Gazetted Officers Association. DGM agreed and directed for necessary action through Establishment.

No. 14: Merger of Grade Pay 4600 with 4800 & 8700 with 8900.

The members raised the issue to expedite case for merger of Grade Pay 4600 with 4800 & 8700 with 8900 which was agreed by IMD and MoES during submission to 7th CPC.

Point No. 15: Meeting with Office bearers of Union/Association.


DGM agreed to fortnightly meeting with the Office bearers of Union/Association.
